(SA info) So when all South Africans speak their lingua franca and their mothertongue they are at least bilingual if not multilingual. What I want to find out here, is whether bilingualism means obtaining several cultures in South Africa or if the use of the powerful SAE, which is also called 'killer-language', leads to a loss of cultures. English, of course, seems to be a global lingua franca and therefore it is powerful and it intends a higher education of its speakers. In South Africa, "fewer than ten per cent of people speak English at home." (Spot on) but "all South African pupils learn English, and it's the language most schools use to teach other subjects." (Spot on). That is a great chance for the pupils but problems arise when some children speak better than their teachers who learned their mothertongue or the former official language, Afrikaans, themselves.
